- **Political-Military Dimension:** This involves promoting arms control, fostering military cooperation, and ensuring the non-proliferation of weapons of mass destruction.
- **Economic and Environmental Dimension:** The OSCE recognizes the link between economic disparities, environmental challenges, and the rise of extremist ideologies. It seeks to address these root causes by promoting economic growth, environmental cooperation, and sustainable development.
- **Human Dimension:** This dimension emphasizes the importance of human rights, rule of law, and democratic institutions in countering terrorism. The OSCE believes that respect for human rights and fundamental freedoms is essential to prevent the spread of extremist ideologies. [3]

2.2 The Role of the OSCE Action against Terrorism Unit

The Action against Terrorism Unit (ATU) operates within the OSCE's Transnational Threats Department and serves as a focal point for the OSCE's 57 participating States and 11 Partners for Co-operation in the realm of counter-terrorism. The ATU's primary objective is to support these states in the implementation of their anti-terrorism commitments. This support is multi-faceted, encompassing a range of counter-terrorism programs and activities, including:

- **Promotion of International Legal Frameworks:** The ATU emphasizes the importance of a universal implementation of the international legal framework against terrorism. This framework facilitates the pursuit and prosecution of terrorists beyond national boundaries, ensuring uniform criminalization of terrorist acts. The ATU collaborates with relevant UN bodies and the Global Counter-terrorism Forum to foster international legal co-operation in terrorism-related cases.
- **Prevention of Violent Extremism:** The ATU is at the forefront of efforts to counter incitement to terrorism and prevent terrorist radicalization. This is achieved by engaging civil society, promoting community policing, and emphasizing youth participation and gender awareness. The Unit also assists in the development and implementation of comprehensive national strategies to counter violent extremism.
- **Counter-Terrorist Financing:** The ATU has developed training courses in collaboration with the United Nations Office on Drugs and Crime. These courses focus on inter-agency co-operation, analysis, investigation, and the disruption of terrorist financial networks.
- **Countering Online Terrorism:** Recognizing the increasing exploitation of the internet by terrorists, the ATU works to identify effective countermeasures. This includes the development of an online course that educates on how terrorists manipulate the internet and how to counter such threats.
- **Protection of Critical Energy Infrastructure:** The ATU engages both public and private sectors in crisis management simulation exercises. These exercises aim to increase the resilience of critical energy infrastructure against terrorist cyber-attacks.
- **Travel Document Security:** The ATU collaborates with the OSCE Border Security and Management Unit to enhance travel document security. This includes supporting states in joining the International Civil Aviation Organization's Public Key Directory and improving the detection of forged travel documents.
- **OSCE Counter-Terrorism Network:** The ATU has established a web-based Counter-Terrorism Network that connects over 1,000 counter-terrorism focal points within

the OSCE. This network facilitates the exchange of information on counter-terrorism programs, legal developments, and global terrorism trends. [4]

The ATU's approach to counter-terrorism is multi-dimensional, ensuring that counter-terrorism measures comply with human rights and fundamental freedoms. The Unit engages various stakeholders, including state authorities, the private sector, civil society, and media, and employs innovative methodologies and tools in its programs.

3. Bulgaria's Alignment with OSCE Counter-Terrorism Objectives

Bulgaria has been actively involved in aligning its national counter-terrorism strategies with the objectives of the OSCE. The country's commitment to counter-terrorism is evident in its participation in international agreements, its national legislation, and overall dedication to collaborative efforts with other OSCE participating states.

3.1 Bulgaria's National Counter-Terrorism Strategies and Their Alignment with OSCE Objectives

- Bulgaria has ratified 12 international conventions and protocols related to terrorism.
- The country has adopted the National Security Strategy of the Republic of Bulgaria, which emphasizes the importance of countering terrorism and radicalization.
- The National Strategy (2015 – 2020) and annual Action Plans on countering radicalization and terrorism have been adopted to confront related threats. These documents involve a multi-institutional approach and close cooperation between authorities at the local and national level, as well as between different stakeholders, like police, social workers, teachers, civil society, and communities.
- Bulgaria is in the process of preparing the adoption of the new national Strategy for Counteracting Radicalization and Terrorism (for the period 2021-2026) with developed new and improved measures, policies, and strategic orientations. [5]

3.2 Specific Initiatives and Programs that Bulgaria has Engaged in Within the OSCE Framework

- Bulgaria has participated in various international agreements and arrangements related to preventing and combating terrorism. These include conventions on offenses committed on board aircraft, conventions against the taking of hostages, conventions on the physical protection of nuclear material, and many more.
- The country has also ratified the main international legal instruments in the field of extradition and judicial cooperation on criminal matters.
- Bulgaria has been a party to multilateral and bilateral agreements containing clauses on cooperation in the suppression of terrorism. These agreements range from cooperation in combating cross-border crime to agreements on police cooperation with various countries. [6]

3.3 Specialized Structures and Strategies for Counter-Terrorism in Bulgaria

- The General Directorate "Gendarmerie, Special Operations, and Combating Terrorism" (GDGSOCT) is a national specialized structure established by the Ministry

of Interior. Its roles include preventing and suppressing terrorist acts, releasing hostages, detecting and neutralizing explosive devices, and more.

- The Ministry of Defence has outlined that the Armed Forces of the Republic of Bulgaria participate in the fight against terrorism both on a national and international level. They provide assistance and support to specialized national structures and perform allied obligations.
- Bulgaria has also adopted the Integrated Border Management Strategy in September 2020, which includes measures such as conducting search and rescue operations at sea, comprehensive risk analysis, enhanced cooperation between national authorities, and the use of the most up-to-date technologies for border management.
